In the Name of God Amen I Hugh Montgomery of Derry-gonelly in the County of Fermanagh Esq<sup>re</sup> being Sick and Weak of Body but of perfect and Sound Memory praised be God for the same, Do hereby make appoint & declare my last Will and Testament in manner and form following hereby revoking all former and other Wills by me made in Writing or otherwise. Imprimis - I leave and bequeath my Soul to God who gave it hoping for Salvation by the Merritts and Suffering of my Saviour and Redeemer Jesus Christ and my body to be buried where and after such decent manner as my Exeors. herein after mentioned shall think fit, and as for all the wordly substance with which it hath pleased Almighty God to bestow upon me far beyond my deserts, I leave give and bequeath as followeth that is to say it is my Will and I order and by these presents appoint that my dearly beloved Wife shall have hold and Enjoy for and during her natural life All that and those the Towns and Lands of the Mannor of Drum<sup>ro</sup> al<sup>s</sup> Dunbar al<sup>s</sup> the Estate of Darrygonelly by whatever Name or Names the same is distinguished or known with all and every part or parcel of the same and the Appurtenances to the same and to every part parcell and farm in any wise belonging with the Rents issues and profits of the same together with my Dwelling House the plate Household Goods and furniture now therein as also twenty of the choice and best of my Cows and ten of my Horses to be chosen and sett out by my Exeors herein after named the said Plate Household Goods and furniture to be by my said Wife disposed of at her death to such of our children only as by their dutiful carage and behaviour towards her she shall think best deserving of the same.  of five Hundred pounds sterg. Item, I leave to my Daughter  
 Jane for her portion four Hundred pounds Ster. Item, I leave  
 to my Daughter Margaret the Sum of Three Hundred pounds Ster.  
 Item, I leave to my Daughter Sidney for her portion the sum  
 of Three Hundred pounds Stg. all the said portions to be  
 paid after such manner and to bear such Interest till paid  
 as in & by the said Deed of Settlement and in and by these  
 presents hereafter is ordered appointed and directed.  
 Item. I leave to my Daughter Sarah six pounds Sterg and to  
 her Husband Brockill Green Six pounds Ster. to buy them  
 mourning. Item I leave to my Eldest son Nicholas and the  
 Heirs Male of his Body to be lawfully begotten for ever,  
 all my real Estate except what is herein after excepted as  
 also the Church Land Lease of the land adjoining and held  
 with Rossculten excepting and always reserving out of the  
 same the Estate of Derrygonelly als the Manor of Dromcro  
 als the Mannor of Dunbar for and during the life of my  
 said wife to which he shall have no title or pretence till  
 after her death, and also excepting and always Reserving  
 out of my said real Estate all such lands and parts and  
 parcells of the mannor of Drumcro' als Dunbarr and the

Mannor of Derranfoghher als the Estate of Monea as by the  
said Deed of Settlement bearing equal date with these  
presents are granted and Settled upon my said sons Hugh  
and Richard to which several Lands so granted to them as  
aforesaid the sd Nicholas shall have no Title claim or  
demand excepting the sum of Four pounds ster per Annum  
from each of them towards the quit or Crown Rent as by  
said Deed of Settmt is expressed and reserved. Item. It  
is my Will and I do hereby desire order & appoint my  
Exeors herein after named and appointed to sell and dispose  
of all the woods on all or any part or parcells of my  
Estates of Derrygonnelly als the Manor of Drumcro als  
Dunbar and the Mannor of Derrynafofher als the Estate of  
Monea (except the wood park in Tullykerbery called Shan  
Mullagh) as also all my other Chattles not otherwise hereby  
disposed of, and that the Money arising from such sale be  
by them applied towards the discharge of my funeral Expences  
my Just Debts and Legacies which it is my will shall be paid  
and my said several Daughters portions, and my will is that  
whatever the Money arising out of my said woods & chattles  
as aforesaid shall fall short of discharging my said funeral  
Expences debts and portions as aforesaid shall be made up  
and paid by my son Nicholas with Interest as mentioned in  
the said Deed of Settlement out of that part of the Estate  
of Monea which comes to the said Nicholas immediately after  
my death. Item, I leave the Sum of five pounds stg to be  
equally divided between the Poor of the Parishes of  
Inasmacksaint and Devonish. Item I do hereby nominate  
Constitute and appoint my dearly and well beloved Wife my  
well beloved friend John Corry of Castle Coole in the County  
aforesd Esq. and my well beloved Brother Robert Montgomery  
of Derrybrusk to my Exeors in Trust to see this my last  
Will and Testament put in Execution and Executed according
